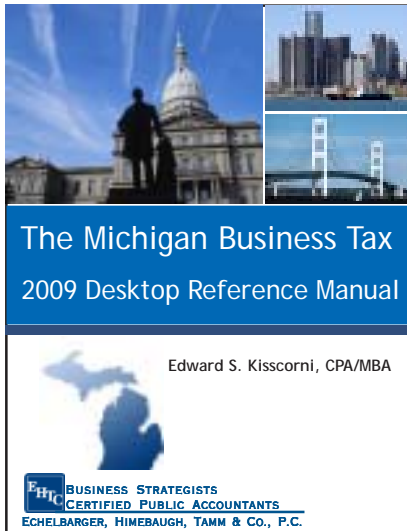

## The Control Test For a Michigan Business Tax Unitary Business Group

The enactment of the Michigan Business Tax Act (MBTA) in July of 2007 brought with it a mandatory unitary filing provision. The MBTA definition of "person" includes a variety of different entity types other than corporations. The definition of "taxpayer" includes a "unitary business group." The unique combinations of these factors create a very difficult challenge. The challenge is to identify a "unitary business group" which can include non-corporate entities and may even include an individual person.

The MBTA defines a "unitary business group" as two or more persons that satisfy both a *control test* and one of two *relationship tests*. The purpose of this book is to provide guidance and instruction to taxpayers and tax preparers on the application of the *control test* for a "unitary business group."

There are numerous specific examples and diagrams to help you determine what constitutes a unitary business group according to the MBT's Control Test.
